



## Consignor Contract and Waiver of Liability

1. Consignor agrees to allow Best Brands Resale to sell any or all items checked into a Best Brands Resale consignment sale. The Consignor is responsible for tagging each item and setting the selling price.
2. Best Brands Resale agrees to pay Consignor 65% of the total sales amount for their items, unless previously arranged. Consignor may earn an additional 10% of the total sales by working at least one four hour shift during the sale.
3. Best Brands Resale reserves the right to refuse any item that does not meet the standards set forth in the consignor guidelines. This includes car seats, items with staining and/or excessive wear, character clothing, clothing from discount stores, and multiples of the same item regardless of size.
4. Consignor agrees to have all items clean, tagged, ironed, and on hangers prior to their drop off appointment. If items are not ready prior to appointment time, items will not be put on the sales floor.
5. Consignor gives consent to Best Brands Resale to act on their behalf in donating to a non-profit charity any items that are not picked up by the end of the designated pick-up time. The pick-up period is Saturday from 2:00pm-3:00pm. Consignor may make arrangements prior to the sale for Best Brands Resale to hold their unsold items for a maximum of 14 days for a fee of \$2 per bin per day. Prior arrangements must be made by midnight EST the day before drop off or items will be considered abandoned and will be donated.
6. Consignor agrees to hold harmless and make no claim against Best Brands Resale, the lessors of the space where the sale is held, any volunteer or paid participants in the sale, or the insurer of Best Brands Resale for any damage, theft or loss of any items consigned to Best Brands Resale. Consignor assumes the risks of these events occurring by participating in the sale.
7. Consignor or Volunteer agrees to waive any and all claims for personal injury resulting from participation in the sale from whatever cause against Best Brands Resale, the lessors of the space where the sale is held, any volunteer or paid participants, or the insurer of Best Brands Resale.
8. Consignor agrees that any items found without a price tag during the sale will be placed in Lost and Found. Consignor may look through these items at pick up for identification. Any items not identified during that time will be donated after the pick-up period is over.
9. Consignor agrees that if they register to consign and then decide not to participate they forfeit the registration fee.
10. This agreement will remain in force for the Best Brands Resale sale unless cancelled in writing by either party and signed by both parties.
